## VBT COVID-19 Travel and Health Declaration

At VBT, the health and safety of our guests and staff is a top priority. We require all guests to **complete and submit this Health and Travel Declaration 72 hours or less** prior to their scheduled VBT tour commencement date. We strongly recommend that you follow these practices when planning your travel to the tour:

- Practice social distancing and minimize contact with other people several days before traveling and while en route.
- Limit travel before the start of the tour to provide a healthier experience for you and fellow travelers.
- Observe all mask-use requirements. While in public, removing your mask is only recommended while eating or drinking.
- Wash hands frequently. When that is not an option, use hand sanitizer.

All guests must be free of COVID-19 and all COVID-19 symptoms at the time of commencing travel. We appreciate your support of our efforts to maintain a safe and healthy travel environment. Please carefully read the following requirements and acknowledge your acceptance:

- I will provide proof of a negative COVID-19 test taken 72 hours or less prior to joining the tour and understand I will not be permitted to join the tour if I do not provide this. Regardless of vaccination status, I understand that a negative COVID-19 test result is required and that I must follow all other mandatory safety measures. Either a negative antigen test or a negative PCR test will suffice; an antibody test is not sufficient. - I understand that the temperature of each guest will be taken on the first day of the tour. A reading below 100.4 F will be required for participation in the tour. The health of all guests will be monitored throughout the tour; this may include additional temperature screenings. I understand that the temperature screenings may not apply if I'm traveling on a self-guided tour; instead I understand that I will be required to self-monitor.
- I certify that I have not been in close contact with someone experiencing COVID-19 symptoms or with someone diagnosed with COVID-19 in the past 14 days. According to the CDC, COVID-19 symptoms include fever, cough, and shortness of breath. Individuals have also reported headache, body aches, sore throat, chills, muscle pain, and loss of smell or taste.

- I certify that I have not experienced any COVID-19-like symptoms in the past 14 days. According to the CDC, COVID-19 symptoms include fever, cough, and shortness of breath. Individuals have also reported headache, body aches, sore throat, chills, muscle pain, and loss of smell or taste.
- I certify that I have not been under quarantine or isolation for COVID-19 in the past 14 days.
- I certify that I have not been diagnosed with COVID-19 in the past 14 days and that I have not tested positive for COVID-19 in the past 14 days.
- I understand that if anyone on my tour becomes ill or starts experiencing symptoms that I may be required to isolate, quarantine, get tested etc.\*
